#### Resolution 8868 (YEAR)

# Adopted by the Security Council at its 8568<sup>th</sup> meeting, on **Insert date**

The Security Council,

Alarmed by the invasion of Belesia on [Date] by the military forces of Olvana,

*Determining* that there exists a breach of international peace and security as regards the Olvanan invasion of Belesia,

Acting under Chapter VII of the United Nations Charter,

- 1. Condemns Olvanan invasion of Belesia,
- 2. *Demands* that the Government of Olvana withdraw all elements of its armed forces from Belesian sovereign territory,
- 3. *Demands* that the Olvanan Government withdraw immediately and unconditionally all its forces to the position in which they were located on [Date],
- 4. *Calls upon* Olvana and Belesia to begin immediately intensive negotiations for the resolution of their differences and supports all efforts in this regard, and especially those of the Association of Southeast Asian Nations (ASEAN),
- 5. *Decides* to meet again as necessary to consider further steps to ensure compliance with the present resolution, and
- 6. *Demands* that the Olvanan authorities comply with their obligations under international law, including international humanitarian law, human rights and refugee law for the maintenance of Regional peace, order and stability.

#### Resolution 8869 (YEAR)

# Adopted by the Security Council at its 8569<sup>th</sup> meeting, on **Insert date**

The Security Council,

Reaffirming its resolution 8868 (Year) of [Date],

Deeply concerned that the resolution has not been implemented and that the invasion of Belesia by Olvana continues with further loss of human life and material destruction,

Determined to bring the invasion and occupation of Belesia by Olvana to an end and to restore the sovereignty, independence and territorial integrity of Belesia,

*Noting* that the Government of Belesia has expressed its readiness to comply with resolution 8868 (Year),

*Mindful* of its responsibilities under the Charter of the United Nations for the Maintenance of International Peace and Security,

Affirming the inherent right of individual or collective self-defence in response to the armed attack by Olvana against Belesia, in accordance with Article 51 of the Charter,

Acting under Chapter VII of the United Nations Charter,

- 1. Determines that Olvana has so far failed to comply with paragraph 2 of resolution 8868 (Year) and has usurped the authority of the legitimate Government of Belesia,
- 2. *Decides*, as a consequence, to take the following measures to secure compliance of Olvana with paragraph 2 of resolution 8868 (Year) and to restore the authority of the Government of Belesia over occupied Belesian territories;
- 3. *Decides* that all states shall prevent:
  - a. The import into their territories of all commodities and products originating in Olvana or occupied Belesia exported there from after the date of the present resolution,
  - b. Any activities by their nationals or in their territories which would promote or are calculated to promote the export or transshipment of any commodities or products from Olvana or occupied Belesia; and any dealings by their nationals or flag vessels or in their territories of any

- commodities or products originating in Olvana or occupied Belesia and exported therefrom after the date of this resolution, including in particular any transfer of funds to Olvana or occupied Belesia for the purposes of such activities or dealings,
- c. The sale or supply by their nationals or from their territories or using flag vessels of any commodities or products, including weapons or any other military equipment, whether or not originating in their territories but not including supplies intended strictly for medical purposes, and, in humanitarian circumstances, foodstuffs, to any person or body in Olvana or occupied Belesia,
- 4. Decides that all states shall not make available to the Government of Olvana, or to any commercial, industrial or public utility undertaking in Olvana or occupied Belesia, any funds or any other financial or economic resources and shall prevent their nationals and any persons within their territories or otherwise making available to that Government or to any such undertaking any such funds or resources and from remitting any other funds to persons or bodies within Olvana or occupied Belesia, except payments exclusively for strictly medical or humanitarian purposes.
- 5. Calls upon all States, including States which are non-members of the United Nations, to act strictly in accordance with the provisions of the present resolution, notwithstanding any contract entered or licence granted before the date of the present resolution.
- 6. Decides that, notwithstanding paragraphs 3 to 4 above, nothing in the present resolution shall prohibit assistance to the Government of Belesia, and calls upon States:
  - a. To take appropriate measures to protect assets of the Government of Belesia and its agencies,
  - b. Not to accept any regime installed or established by the occupying power,
- 7. *Requests* the Secretary-General to report to the Security Council on the progress made in the implementation of the present resolution,
- 8. *Decides* to keep this item on its agenda and to continue its efforts to put an early end to the Olvanan invasion of Belesia.

#### Resolution 8873 (YEAR)

# Adopted by the Security Council at its 8573<sup>rd</sup> meeting, on **Insert date**

The Security Council,

Recalling its previous debates and the statements of its President and member states concerning the security situation in Belesia and its **Resolutions 8868** and **8869** and in particular **paragraphs 2 and 3** of UNSCR 8868,

Condemning all acts of state-sponsored intimidation and threats of armed force affecting the legitimate sovereignty of other nations,

*Deploring* the continued and systematic increase in political and military intimidation and threats being directed towards Belesia by Olvana,

Condemning in the strongest possible terms the recent armed invasion of Belesian territory by elements of the Olvanan armed forces and the commencement of offensive operations and hostilities in Belesia,

*Deploring* the loss of innocent lives and the destruction of property in Belesia by elements of the Olyanan armed forces.

*Expressing* its determination to support all efforts to promote lasting peace and stability in the Pacific Region, and to build a prosperous and united environment wherein human rights are respected and the protection of all citizens is assured,

Reaffirming the political will and determination of its members to take whatever measures necessary, up to and including the deployment of military forces, to restore peace and protect the sovereignty of nations faced with state-sponsored aggression and intimidation wherever and whenever such situations may arise in the world,

*Reaffirming* its commitment to the sovereignty, unity, independence and territorial integrity of Belesia, and *recalling* the importance of the principles of good neighbourliness, non-interference and regional cooperation,

Condemning all acts of violence and violations of human rights and international humanitarian law by all parties, and *emphasizing* the need for perpetrators of all such crimes to be brought to justice without delay,

Expressing concern at the plight of refugees forced to flee instability and unrest in Belesia,

*Reaffirming* its strong commitment to the sovereignty, independence, territorial integrity and national unity of Belesia as a nation,

*Recalling* in this regard that all parties must respect human rights and international humanitarian law,

Taking note of its previous debates and the statements of its President and member states concerning the deteriorating security situation in the Pacific, with specific reference to Olvanan military aggression against Belesia,

Determining that the situation in the Pacific, specifically the actual commencement of offensive military operations by Olvana against Belesia, constitutes a threat to international peace, security and stability in the region,

Acting under Chapter VII of the United Nations Charter,

- 1. *Demands* that the Government of Olvana and any proxy and/or irregular forces subordinate to it immediately cease all provocative and hostile military and diplomatic actions, specifically those directed towards the sovereign nation of Belesia, and directly threatening the security and sovereignty of the Belesian people and the broader Pacific Region,
- 2. *Demands* that the Government of Olvana withdraw all elements of its armed forces from Belesian sovereign territory,
- 3. *Demands* that the Olvanan authorities comply with their obligations under international law, including international humanitarian law, human rights and refugee law, for the maintenance of Regional peace, order and stability,
- 4. *Authorizes* its member states with reference to Chapter VII, Articles 46 and 47 of the United Nations Charter, to establish and deploy a multinational military force in Belesia International Belesian Security Assistance Force (IBSAF) to enforce an end to state-initiated hostile action by Olvana and other belligerents, with the following objectives:
  - a. The expulsion of Olvanan forces from Belesian territory, the <u>restoration</u> and <u>maintenance</u> of Belesian sovereignty and the <u>deterrence</u> of any further external aggression against Belesian sovereign territory;
  - b. The preservation of human life and the alleviation of suffering for affected populations within Belesia, including the facilitation of humanitarian aid programs;
  - c. The re-establishment of a safe and secure environment in Belesia within which the national government can pursue its own programs for national development, peace and prosperity.
- 5. *Directs* that the multinational military coalition (IBSAF) will work within the following general parameters
  - a. Overall command and control to be exercised by Australia;

- b. Initial troop contributing nations Australia, New Zealand, Fiji, and Indonesia to be augmented by resources (all types) of other member states;
- c. The primary focus of operations to be within the territorial boundaries of Belesia. Operations elsewhere in theatre may be conducted if required to support or achieve the objectives set out in paragraph 4 above;
- d. All coalition operations within Belesia to be undertaken in full coordination and cooperation with Belesian authorities and forces, cognizant of the sovereign authority of the Government of Belesia, its Departments, Agencies and officials;
- e. The coalition force to be established, deployed and conduct operations in Belesia for an initial period of twelve months post arrival in theatre with extensions and/or termination of activities to be determined by discussions within the Security Council;
- f. Coalition military operations to minimize any adverse environmental and economic impacts in Belesia and in the Pacific more broadly to facilitate a rapid return to peacetime conditions and the commencement of follow-on development activities after the cessation of hostilities.
- 6. Strongly Recommends that the Governments of Olvana and Belesia immediately commence negotiations to resolve their bilateral issues in order to reach an agreement to end hostilities which will be fully and transparently implemented, with the appropriate international monitoring as necessary and as agreed by both nations,

#### **Protection of Civilians**

7. Authorizes Member States acting nationally or through international organizations or arrangements, and acting in cooperation with the Secretary General to take all necessary measures to protect civilians and civilian populated areas under threat of attack in Belesia and requests the Member States concerned to inform the Secretary General immediately of the measures they take pursuant to the authorization conferred in this paragraph which shall be immediately reported to the Security Council.

#### Other matters

- 8. Requests all United Nations organizations to coordinate their humanitarian efforts with the SRSG and the HRC and urges all other non-government agencies operating in, or planning to operate in, Belesia to coordinate their activities with the HRC,
- 9. *Declares* its commitment, upon the cessation of hostilities, to assist the people of Belesia in their efforts to establish a peaceful, united and prosperous nation,
- 10. *Urges* the various agencies of the United Nations, the World Bank and other parties, in association with other bilateral and multilateral donors, to continue their efforts to prepare for the rapid delivery of an assistance package for the

reconstruction and economic development of Belesia, including official development assistance, possible debt relief and trade access, to be implemented upon cessation of hostilities,

- 11. Welcomes the initiative of the Government of Torrike to convene an international donors' conference for the reconstruction and economic development of Belesia upon the cessation of hostilities,
- 12. *Reiterates* its readiness, upon the cessation of hostilities, to consider establishing a subsequent United Nations peace support operation and reiterates its request to the Secretary-General to submit to the Council, as soon as possible post the cessation of hostilities, recommendations for the size, structure and mandate of such an operation, including a timetable for its deployment,
- 13. *Emphasizes* that an agreement to cease hostilities will contribute towards sustainable peace and stability throughout the Pacific Region and to the efforts to address the crisis in Belesia, and underlines the need for a national and inclusive approach, including the role of women, in line with SCR 1325, towards reconciliation and peace-building,
- 14. *Strongly* urges Member States to provide the equipment, logistical, financial, material, and other necessary resources to the multilateral military coalition established under paragraph 4 above,
- 15. Reiterates its call on Member States to provide urgent and generous contributions to the humanitarian efforts underway in Belesia,
- 16. *Requests* the Secretary-General to keep it regularly informed of developments in Belesia and the Pacific Region, and to make any recommendations for action to ensure implementation of this resolution and its previous resolutions.
- 17. *Commits* to remain seized of this matter until a satisfactory conclusion is reached as outlined in paragraph 4 above.

Resolution 8882 (YEAR)

# Adopted by the Security Council at its 8599<sup>th</sup> meeting, on **Insert date**

The Security Council,

*Recalling* its previous debates and the statements of its President and member states concerning the security situation in Belesia and its **Resolutions 8868, 8869** and **8873**,

Reaffirming its strong commitment to the security, stability and territorial integrity of Belesia,

Reaffirming the basic principles of peacekeeping, including consent of the parties, impartiality, and non-use of force, except in self-defence and defence of the mandate, and recognizing that the mandate of each peacekeeping mission is specific to the need and situation of the country concerned, understanding multidimensional peacekeeping operations facilitate the diplomatic/political process, protect civilians, assist in the disarmament, demobilization and reintegration of combatants; and assist in restoring the rule of law, and that peacekeeping operations may use force to defend themselves, their mandate, and civilians,

Condemning strongly the offensive launched on XXXXXX by Olvana and the continued criminal acts of extremist and armed groups operating in Belesia (Panay) and stressing that coordinated de-stabilizing actions can only be defeated by a sustained and comprehensive approach involving the active participation and collaboration of all States, and regional organizations to impede, impair, and isolate the threat, and reaffirming that extremism and criminal activities could not and should not be associated with any religion, nationality or civilization,

Welcoming the swift action by the International Belesian Security Assistance Force (IBSAF), at the request of the United Nations and the authorities of Belesia (Panay), that stopped the offensive of Olvana and the extremist acts of unrestrained insurgents, criminals and armed groups in Panay and commending the actions that restored the territorial integrity of Belesia by the Belesian Defence and Security Forces, with the support of the IBSAF,

*Insisting* that all parties respect and are in compliance with all aspects of the Cease Fire Agreement,

Stressing the need to work expeditiously toward the restoration of a secure and stable environment essential for democratic governance and constitutional order, and *emphasizing* the importance for the authorities of Belesia to move swiftly in a process of

inclusive dialogue and active engagement with Panayan political groups, including those who have previously advocated independence, are prepared to cease hostilities, have cut off all ties with terrorist organizations and who recognize, without conditions, the unity and territorial integrity of the Belesian State,

Remaining seriously concerned over the significant ongoing food and humanitarian crisis in Panay and over the insecurity which hinders humanitarian access, exacerbated by the presence of armed groups, extremists and criminal networks, and their activities, the presence of landmines as well as the continued proliferation of weapons from within and outside the region that threatens the peace, security, and stability of States in this region,

*Emphasizing* the need for all parties to uphold and respect the humanitarian principles of humanity, neutrality, impartiality and independence in order to ensure the continued provision of humanitarian assistance, the safety of civilians receiving assistance and the security of humanitarian personnel operating in Belesia and *stressing* the importance of humanitarian assistance being delivered on the basis of need,

Condemning strongly the reports of retaliatory attacks and criminal acts perpetrated against civilians, and calling upon all parties to bring an end to such violations and abuses and to comply with their obligations under applicable international law,

Expressing its continued concern over the serious threats posed by transnational organized crime in the Panayan region, and its increasing links, in some cases, with extremism, and strongly condemning the criminal acts conducted with the aim of raising funds or gaining political concessions, noting the increase in such criminal acts in the Panayan region, and underscoring the urgent need to address these issues,

Commending the International Belesian Security Assistance Force, and the Association of Southeast Asian Nations (ASEAN), as well as the Secretary-General, for their intensive efforts to end hostilities in Belesia, welcoming the establishment by the United Nations of a Combined Joint Task Force for Belesia, encouraging them to maintain coordination in support of the stabilization of the situation in Belesia,

Commending the contributions pledged at the Donors conference organized by the UN in New York on Date XXXX in support of the IBSAF and the Belesian Defence and Security Forces, welcoming actual contributions already made, urging all donors to translate their pledges into actual contributions and calling upon other Member States and regional and international organizations to also contribute generously,

Taking note of the letter, dated Date XXXX, addressed to the Secretary-General by the authorities of Belesia, which requests the deployment of a United Nations operation to assist in the stabilization and restoration of a secure environment to support the authority and the sovereignty of the Belesian State in Panay,

Taking note of the letter, dated Date XXXX, addressed to the Secretary-General by the Chairman of the UNSC recommending the transformation of IBSAF into a United Nations stabilization mission and *taking note* of the communiqué, dated Date XXXX, of the ASEAN, expressing ASEAN support for the transformation of IBSAF into a United Nations stabilization operation in Belesia (Panay),

*Taking note of* the report of the Secretary-General. Dated Date XXXX, on the situation in Belesia (Panay), including recommendations and options for establishing a United Nations stabilization operation in Panay,

Emphasizing that the authorities of Belesia have primary responsibility for resolving the interlinked challenges facing their country and protecting all their citizens and that any sustainable solution to the crisis in Belesia should be Belesian-owned, also emphasizing that the cooperation among the countries of the region will be crucial for lasting peace and stability in Belesia,

Encouraging the international community to provide broad support to resolve the crisis in Belesia through coordinated actions for immediate and long-term needs, encompassing security, development and humanitarian issues, *looking forward* to the high-level international donors' conference in Brussels on Date XXXX to support the development of Belesia,

Acting under Chapter VII, Article 42 of the Charter of the United Nations,

- 1. Commends the initial measures taken so far to restore order and national unity in Belesia, and calls on the authorities of Belesia to continue urgently to take discernible steps towards consolidating stability and facilitating inclusive political dialogue to bring about a process of national reconciliation and to foster social cohesion, which should lead to political progress in this regard as early as possible;
- 2. *Requests* the Secretary-General, in close coordination with ASEAN, to support all dimensions of any long-term stabilization plans to be developed, with a view to their swift implementation;
- 3. Demands that all rebel armed groups in Belesia (Panay) put aside their arms and cease hostilities immediately and urges all such parties in Belesia who have cut off all ties with extremist organizations and who recognize, without conditions, the unity and territorial integrity of the Belesian State, and the authorities of Belesia to engage expeditiously in an inclusive negotiation process, facilitated by the Secretary-General, in particular through his Special Representative for Belesia;
- 4. *Decides* to establish the United Nations Mission in Belesia (UNMIB), with UNMIB assuming responsibility for the discharge of IBSAFs mandated tasks, as of the date of adoption of this resolution, further decides that the authority be transferred from IBSAF to UNMIB on Date XXXX at which point UNMIB shall commence the implementation of its mandate for an initial period of 12 months;
- 5. Decides that the date referred to in paragraph 4 above and UNMIB's phased deployment shall be subject to a further review by the Council within 60 days of the adoption of this resolution of the security situation in UNMIB's area of responsibility, specifically with respect to the cessation of major combat operations by international military forces in the immediate vicinity of and/or within UNMIB's envisaged area of responsibility and a significant reduction in the capacity of extremist and criminal groups to pose a major threat to the civilian population and international personnel in the immediate vicinity of and/or within UNMIB's envisaged area of responsibility, further decides, should the Council consider that these criteria are not met before Date XXXX, it shall concurrently adjust the timeline for UNMIB's deployment against these criteria;
- 6. Reiterates that Member States and regional and international organizations are urged to continue to provide coordinated support to IBSAF pursuant to its resolution 8873, until

the transfer of authority from IBSAF to UNMIB, including military training, provision of equipment, intelligence and logistical support;

- 7. Reaffirms that the Special Representative for Belesia has overall authority on the ground for the coordination of all the activities of the United Nations, and assigns additional responsibilities as Head of Mission of UNMIB, and who shall use good offices and coordinate efforts of the international community in order to support the priority elements of the mandate and who shall, from the transfer of authority from IBSAF to the mandate of UNMIB coordinate the overall support of the international community in Belesia:
- 8. Decides that UNMIB will comprise up to XX,XXX military personnel, including reserve battalions capable of deploying rapidly within the country as and when required, and X,XXX police personnel, calls upon Member States to provide troops and police with adequate capabilities and equipment in order to enhance the capacity of UNMIB to operate, and discharge its responsibilities, effectively and requests the Secretary-General to recruit qualified staff, who have the professional experience and skills appropriate to the tasks;
- 9. Decides that the mandate of UNMIB shall be the following:
  - a. *Monitor* and ensure compliance with the Cease Fire Agreement;
  - b. *Stabilization* of its Area of Responsibility and support for the reestablishment of a safe and secure environment:
    - i. In support of the authorities of Belesia, to stabilize the key population centres, especially in Panay and, in this context, to deter threats and take active steps to prevent the return of armed elements to those areas;
    - ii. To support the authorities of Belesia as required extending and reestablishing State administration in Panay;
    - iii. To support national and international efforts towards repairing the damaged Belesian security sector, within its capacities and in close coordination with other bilateral partners, donors and international organizations engaged in these fields, including the ASEAN;
  - c. Protection of civilians and United Nations personnel
    - i. To protect, without prejudice to the responsibility of the Belesian authorities, civilians under imminent threat of physical violence, within its capacities and areas of deployment;
    - ii. To provide specific protection for women and children affected by armed conflict, including through the deployment of Child Protection Advisors and Women Protection Advisors, and address the needs of victims of sexual and gender-based violence in armed conflict;
    - iii. To protect the United Nations personnel, installations and equipment and ensure the security and freedom of movement of United Nations and associated personnel;
  - d. *Promotion* and protection of human rights
    - i. To monitor, help investigate and report to the Council on any abuses or violations of human rights or violations of international humanitarian law

committed in Panay and to contribute to efforts to prevent such violations and abuses;

- ii. To assist the authorities of Belesia in their efforts to promote and protect human rights;
- e. Support for humanitarian assistance
  - i. In support of the authorities of Belesia, to contribute to the creation of a secure environment for the safe, civilian-led delivery of humanitarian assistance, in accordance with humanitarian principles, and to assist in the voluntary return of internally displaced persons and refugees in close coordination with humanitarian actors:
- 10. Authorizes UNMIB to use all necessary means, within the limits of its capacities and areas of deployment, to carry out its mandate as set out in the paragraphs above and requests UNMIB's civilian and military components to coordinate their work with the aim of supporting the tasks outlined in paragraphs above;
- 11. *Urges* all parties in Belesia to cooperate fully with the deployment and activities of UNMIB, in particular by ensuring their safety, security and freedom of movement with unhindered and immediate access throughout its Area of Responsibility to enable UNMIB to carry out fully its mandate;
- 12. Calls upon Member States, especially those in the region, to ensure the free, unhindered and expeditious movement to and from Belesia of all personnel, as well as equipment, provisions, supplies and other goods, including vehicles and spare parts, which are for the exclusive and official use of UNMIB;
- 13. *Urges* the authorities of Belesia to ensure that all perpetrators of serious violations and abuses of human rights and serious violations of international humanitarian law are held accountable within its own national criminal jurisdiction and to cooperate with the International Criminal Court as necessary, in accordance with Belesia's obligations under the Rome Statute;
- 14. *Urges* Pacific Regional States to enhance interregional cooperation and coordination in order to develop inclusive and effective strategies to combat in a comprehensive and integrated manner the activities of extremist and criminal groups, and prevent the expansion of those groups as well as to limit the proliferation of all trans-national organized crime;
- 15. Requests the Secretary-General to ensure full compliance of UNMIB with the United Nations zero-tolerance policy on sexual exploitation and abuses and to keep the Council fully informed if such cases of misconduct occur;
- 16. Requests the Secretary-General and the authorities of Belesia to conclude, within 30 days of the adoption this resolution, a status-of-forces agreement with regards to UNMIB;
- 17. Requests the Secretary-General to keep the Council regularly informed of the situation in Belesia and the implementation of the mandate of UNMIB, to report to the Council within 45 days of the adoption of this resolution, and then every three months and to include in his reports to the Council updates on the security situation, relevant information on the progress, promotion and protection of humanitarian assistance programmes as well as a review of the troop level, force generation and deployment of all UNMIB's constituent elements;

# Adopted by the Security Council at its 8611th meeting, on **Insert date**

The Security Council,

*Recalling* its Resolutions 8868, 8869, 8873 and 8882, and all previous resolutions and statements of its President pertaining to the Olvanan - Belesian conflict,

*Reaffirming* the commitment of all Member States to the sovereignty, independence and territorial integrity of Atropia,

Further reaffirming the need for both parties to fulfil all their obligations under international humanitarian, human rights and refugee law,

*Recalling* the relevant principles contained in the Convention on the Safety of United Nations and Associated Personnel adopted by the General Assembly in its resolution 49/59 of 9 December 1994,

Expressing its strong support for the Agreement on Cessation of Hostilities between the Government of Belesia and the Government of Olvana, and the official communications by each Government requesting United Nations assistance in the implementation of this Agreement,

Welcoming the report of the Secretary-General of XXXXX (S/XXXX),

Recalling its resolution 8873, that established the International Belesian Security Assistance Force (IBSAF), and 8882 that called for the establishment of a Peacekeeping Force (UN Mission in Belesia – UNMIB) and the conduct of stabilization operations;

- 1. *Calls* on the parties to fulfil all their obligations under international law, including the Agreement on Cessation of Hostilities;
- 2. Authorizes the deployment of a UN Peacekeeping Force of up to XXXX troops, including up to 220 military observers, until XXXXX, with a mandate to:
  - a. *Monitor* the cessation of hostilities;
  - b. Assist, as appropriate, in ensuring the observance of the security commitments agreed by the parties;
  - c. Monitor and verify the redeployment of Olvanan troops to positions in Olvana;

- d. *Monitor* the cessation of hostilities between ethnic factions on Panay;
- e. *Coordinate* and provide technical assistance for humanitarian mine action activities in Panay;
- f. *Coordinate* the Mission's activities in Panay with humanitarian and human rights activities of the United Nations and other organizations in those areas;
- 3. *Welcomes* the intention of the Secretary-General to confirm the Special Representative of the Secretary General (SRSG) who will be responsible for all aspects of the United Nations work in fulfilment of the mandate of the Mission;
- 4. *Requests* the Secretary-General to coordinate with all parties in the continued implementation of the Agreement on the Cessation of Hostilities;
- 5. Calls on the parties to take whatever action may be necessary to ensure the Mission's access, safety and freedom of movement, and to provide the assistance, support and protection required for the performance of its mandate in all areas of its operation deemed necessary by the Secretary-General;
- 6. Requests the Government of Belesia to conclude, as necessary, status-of-forces agreements with the Secretary-General within 30 days of adoption of this resolution, and recalls that pending the conclusions of such agreements, the model status-of-forces agreement of 9 October 1990 (A/45/594) should apply provisionally;
- 7. Calls on all parties to assist the UN in de-mining activities by providing complete and accurate information on minefields and mines in the conflict area: and Urges the parties to proceed immediately with demining, in order to ensure safe access of United Nations and associated personnel to the areas being monitored, drawing on United Nations technical assistance as needed;
- 8. *Calls* on the parties to ensure the safe and unhindered access of humanitarian personnel to all those in need;
- 9. *Further* calls on all parties to cooperate with the International Committee of the Red Cross/Red Crescent;
- 10. Acting under Chapter VI of the Charter of the United Nations and further to the provisions of its resolution 8882 decides to authorize that the sale and supply of:
  - a. Arms and related matériel for the sole use in Belesia and Olvana of the United Nations, and
  - b. Equipment and related matériel, including technical assistance and training, for use solely for demining within Belesia under the auspices of the United Nations Mine Action Service:
- 11. *Encourages* all States and international organizations to assist and participate in the longer-term tasks of reconstruction and development, as well as in the economic and social recovery of Belesia;
- 12. *Requests* the Secretary-General to keep the Council closely and regularly informed of progress towards the implementation of this resolution;
- 13. *Emphasizes* that the Agreement on Cessation of Hostilities links the termination of the United Nations peacekeeping mission with the completion of the process of redeployment of Olvanan forces from Belesia, and requests the Secretary-General to provide regular updates on the status of this issue;

- 14. *Calls* on the parties to continue negotiations and conclude without delay a comprehensive and final peace settlement;
- 15. *Decides* that the Council, in considering the renewal of the mandate of the Mission, will take into account whether the parties have made adequate progress as called for in paragraph 13 and 14 above;
- 16. Decides to remain actively seized of the matter.
